《Terms for Rescheduled Performance(s) Ticket(s) Registration》

- Registration Period: 24th October 2020 to 1st November 2020.
- 2. A ticket holder with the original(s) of valid ticket(s) (with ticket stub(s) intact) for the performance(s) from 22nd November 2019 to 25th November 2019 shall be eligible for registration.
- 3. Each person shall only be eligible to register for up to four (4) tickets.
- 4. The Organiser may require a person to provide more information in case there are any suspicious ticket registrations.
- 5. If the information printed on the tickets was found erased or altered, or damaged, defaced or incomplete, or a person fails to provide copy of the purchase confirmation e-mail, the organiser reserves the right to refuse any registrations.

 Any counterfeit tickets or purchase confirmation e-mail if found will be reported to the police. Any person who dishonestly obtained or attempted to obtain any benefits by any fraud, false statements or deception under the Theft Ordinance (Cap. 210) and by making or using a counterfeit ticket under the Crimes Ordinance (Cap. 200) commits a criminal offence liable to imprisonment. Any offender will be prosecuted. Please do not attempt to break the law.
- 6. The Organiser shall not be responsible for making any arrangements for reporting lost tickets. Any person who fails to provide valid admission ticket(s) (with ticket stub(s) intact) shall not be entitled to exchange new ticket(s) or attend the rescheduled performance(s).
- 7. The personal information collected by means of the request form will only be used for the purpose of verifying and processing registration. Such information will be destroyed once the registration process has been completed.
- 8. The Organiser shall send out a confirmation e-mail / SMS with new seat(s) information no later than 13th November 2020.
- 9. A ticket holder must present the original of the valid ticket (with ticket stub intact) for exchanging new ticket(s):

Date: 15th November 2020 – 21st November 2020 (For all rescheduled performances)

Time: 11:00am - 8:00pm

Place: Hong Kong Coliseum - Piazza

OR

Date: 22nd November 2020 – 25th November 2020 (Only for the day of rescheduled performance)

Time: 11:00am - 6:00pm

Place: Hong Kong Coliseum - Piazza

- ♦ Upon collection of tickets, ticket holder must present the confirmation e-mail / SMS with the reference number, and all registered admission ticket(s) (with ticket stub(s) intact) of original concerts.
- 10. If there is any problem of tickets found during admission, the Organiser will handle in accordance with the information registered by the ticket holders. In case of any dispute, the organiser reserves the right of final decision.

- 1. Please complete Part 1 of the form: Ticket holder's details.
- 2. Please complete Part 2 of the form: Required information for registration.
- 3. Please sign the completed request form to indicate your agreement and acceptance to abide by the terms for registration. This form must be completed and signed, otherwise the organiser may refuse to process your registration. In any event, the Organiser shall not subsidise any postal fees.
